- 4.2 <u>Moved</u> Dudley Maier of 51 Chatsworth Road, Highgate, <u>Seconded</u> Dan Caddy of 1 Eucla Street, Mt Hawthorn
  - (1) That the community:
    - (a) recognises and values the community building aspects of dog offleash exercise areas and that this community building include a diverse range of residents.
    - (b) accepts that the most efficient use of parks and oval involves the sharing of those resources.

- (2) That the community requests the Town:
  - (a) formally recognises the value of the community building benefits of providing dog off-leash exercise areas;
  - (b) formally recognises and respects the needs of dog owners to have access to dog exercise areas;
  - (c) engages dog owners within the Town to determine their needs;
  - (d) develops a programme to meet those needs;
  - (e) allocates sufficient funds and resources to meet those needs and that such funds and resources should be on par with those allocated to various sporting groups and facilities; and
  - (f) promotes and encourages responsible dog ownership within the Town.

Mr Dan Caddy expressed general support for the motion, except for clause (e), which he considered too open in respect to funding.

AMENDMENT CARRIED (9 in favour, 7 against)

#### SUBSTANTIVE MOTION CARRIED UNANIMOUSLY

# 4.3 Ms Marie Slyth of 89 Carr Street, West Perth spoke as follows:

Spoke about the issue of consultation. Requested that the Town address the need for early consultation with the community for all developments of every scale and the corresponding need for the Council Executives, especially the Planning Department, collectively with the elected Councillors.

Also added that she believes the Council exists to serve the ratepayers and not to act separately or to assume a power role in any way.

Acknowledged the excellent achievements of the Council to date and also some of the recent attempts of improving community consultation.

Wants direct true democracy, with no hidden Council agendas, with no serious conflicts with the community.

Mayor Catania responded and reflected a number of statements. He stated that "robust" debate should not be construed as conflict as he believes none exists on the Council. He firmly stated that he and the Council operates to serve the community.

# 4.4 Ms Shirley Benton of 41 Smith Street, Highgate

Stated that she is on the Taskforce of the Town's Community Visioning Project and advised that a large number of people had attended the "walks of interest" and the full day workshops and Saturdays. Stated she believes the project to be a huge outstanding success and far outweighs other community consultation carried out before.

Requests that the Council re-affirms its support for the Vincent Vision 2024 as a means of determining the community's desires and aspirations for the Town and that the outcome of the Community Visioning process be truly reflected in the amended Town Planning Scheme
