### 3. (a) PUBLIC QUESTION TIME & RECEIVING OF PUBLIC SUBMISSIONS

The following submissions were made by persons in the Public Gallery:

John Waddingham of 23 Anzac Road, Leederville - Spoke on Item 7.1. Stated he 1. was sceptical as to the stated reasons for why the meeting will be closed to the public. Stated while he had not seen the report, he thought it unlikely a report of this nature would contain any information specific to any employee. He acknowledged that boundary changes and amalgamations, if they occur, may affect some employees, but everyone already knew that. In the event of amalgamation, employees in the front line of job changes would be senior executives and they would be present at the closed meeting anyway. On the matter of commercial sensitivity of proceedings, he felt that because the Town's report was a position paper which had yet to be assessed by or negotiated with other entities and finalised, it was most unlikely to contain anything of 'actionable' commercial value. Asked Council Members if they agreed with the reasons given? Asked if this is also happening in other Councils. Advised he looked at the WALGA and Department of Local Government websites and learnt, amongst other things, that community consultation processes were recommended for the April and May Stage 2 of the reform submission and that many Councils have already or are conducting community consultation. Stated a WALGA survey reviewed that the community is interested in this issue and want to have a say. Stated the Department and WALGA recognise the potential impact on some of the employees and have or are creating mechanisms to protect employees interests. Feels the Town hasn't offered any opportunity for community consultation.

- (H) Review of the Local Government Reform Steering Group's findings and Recommendations Regarding Reform Matters
  - (a) NOTES that this item has been DEFERRED until the findings and recommendations from the Department of Local Government on the Town's Checklist be received;
- (iii) DEFERS making a final decision on the future of the Town's boundaries/structural reform until it has received further information concerning the options available and the outcome of submissions it receives as a result of the proposed community consultation;
- (iv) AUTHORISES the Chief Executive Officer, in liaison with the Mayor and the Town's Project Team, to;
  - (a) implement and progress the recommendations (as amended by clause (ii)(G)(a) above) of the Town of Vincent Project Team as detailed in this report and the Town's Project Team Minutes; and
  - (b) prepare a reform submission for the Council's consideration and adoption, prior to being submitted to the Minister for Local Government by 31 August 2009;
- (v) NOTES:
  - (a) the Town's Chief Executive Officer has submitted an Application for Funding to the Department of Local Government for \$10,000;
  - (b) the letters from the City of Stirling and City of Bayswater, as shown in Appendix 7.1D and 7.1E; and

# LEGAL:

At the Ordinary Meeting of Council held on 28 April 2009 the Council considered a report on Local Reform Strategies 2009 and resolved (in part) as follows:

"(iv) RESOLVES that until the Chief Executive Officer makes public the final confidential report to the Chair of the Local Government Reform Steering Committee, or any part of it, concerning the Council's response to the Minister for Local Government's directive of 5 February 2009 for Councils to advise him of their intentions to amalgamate or reduce the number of Council elected members, this report and any subsequent reports and/or matters relating to it, be kept CONFIDENTIAL."

The Local Government Act 1995, Section 5.23(2) prescribes that a meeting or any part of a meeting may be closed to the public when it deals with a range of matters.

Section 5.94 of the Act provides the public is entitled to inspect a wide range of information about the Town. Section 5.95(6) excludes information that has been prescribed as confidential from this entitlement.

In the interests of enabling the Council to engage in free and open debate in determining the Town's response to the Minister's directive of 5 February 2009, it is suggested information which is to be considered during deliberations be prescribed as confidential.

The Town of Vincent Local Law Relating to Standing Orders states the following:

### *"2.15 Confidential business"*

(1) All business conducted by the Council at meetings (or any part of it) which are closed to members of the public is to be treated in accordance with the Local Government (Rules of Conduct) Regulations 2007.

The confidential report is provided separately to Council Members, the Chief Executive Officer and Directors.

At the conclusion of these matters, the Chief Executive Officer may wish to make some details available to the public.
