#### **PURPOSE OF REPORT:**

To present the Fees and Charges for the financial year 2005/2006 for approval.

#### **BACKGROUND:**

The Town of Vincent, as all other local authorities, applies charges for services provided and for the use of facilities available for hire. All such fees are required to be reviewed annually.

The Local Government Act 1995 allows fees and charges to be adopted and included in the Annual Budget without having to be gazetted separately.

#### **DETAILS:**

The attached schedule outlines details of Fees and Charges proposed for the 2005/2006 year with a comparison to last year's fees, where there has been a change from last year the particular item has been highlighted in bold italics.

A number of fees are determined by legislation, these include Dogs and Building/Planning Fees and a number of fees are raised under the Health Act.

Fees and Charges that are raised where the Town is engaged in what is deemed to be commercial activity, GST must be applied. Fees where GST is applicable are marked with a tick in the last column of the schedule.

Local Government Fees and Charges that are raised under legislation or local laws are in general GST free by way of exemption through Division 81 of the GST Legislation.

#### New fees recommended for 2005/2006 include:

#### Health Fees

Benchmarking with other metropolitan councils and the adoption of new Health Local Laws has resulted in the establishment of a number of new fees listed on pages 8.2 and 8.3.

# Increased charges have been recommended in the following areas:

# Dog Pound

An increase in the fees associated with the Dog Pound is proposed to reflect inflationary increases, these have not been increased for a number of years.

# **Abandoned Vehicles**

An increase in the towing fees is proposed to reflect cost increases.

# Car parking fees/day

An increase in both the hourly and all day fees are proposed for this financial year.

# Car parking fees/night

An increase in fees also has been proposed in the night fees.

# **Loton Park Temporary Parking Fees**

A slight increase is proposed.

# **Health Fees**

The Executive Director Public Health now reviews prescribed fees on an annual basis to prevent periodic substantial increases.

# **Sundry Information**

# Zone and Order Search Enquiries

The Town receives approximately 1,100 of those enquiries per year. The current fee of \$40.00 should be increased to reflect the full cost of recovery of the enquiry search.

This is the second year for this fee. The increase is CPI, as prescribed in the Heads of Agreement (Deed of Clarification).

#### **Building Plan Copies**

Increases proposed to reflect cost recovery of the task.

# Planning and Building Policy and Town Planning Scheme Maps

Increases proposed to align with full cost recovery of the task.

# **Development Applications**

Renewals and modification to previously assessed and approved conditions. In 2004/2005 the fees were 50% of scheduled fees. In 2005/2006 the following is proposed:

- Development application assessment has been undertaken, minor amendments to plans or application 25% of paid fees.
- Major amendments to plans or application 50% of paid fees.
- New development application for reconsideration of a condition(s) on previous valid planning approval \$100
- New development application for a previously determined development 100% of scheduled fees.

# Hire of Hall and Community Centres

Increase in a number of fees in this area to reflect inflationary pressures, of the cost of maintaining these venues. The level of hire fees for these facilities have remained the same for several years.

# Cash in Lieu

Cash in lieu payment for car parking to be adjusted for 2005/2006 to each car parking bay or part thereof: \$2,600 equals construction component plus 50% of land value of the property (as determined by the Valuer General) per square metre multiplied by the car bay area (land component).

#### Works Bonds

A substantial fee increase is proposed to reflect the full cost of recovery of damage caused to the Town's infrastructure (p8.10).

# **Sports Grounds and Reserves**

A small increase is proposed.

#### Beatty Park

A review of Beatty Park fees in comparison to other centres is conducted annually.

Beatty Park fees and charges are adjusted each year to minimise significant increases and to ensure the centre remains competitive as well as meeting its community obligations.

#### Sports Grounds and Reserves

It is proposed to increase the fees for the use of the sportsgrounds and reserves for the next financial year. These fees have remained at the same level for a number of years and are due to be reviewed.

#### **PURPOSE OF REPORT:**

# **CONSULTATION/ADVERTISING:**

There will be a need to advertise the above proposal on a Statewide and local publication basis for six (6) weeks and to seek public comment on the proposed amendments.

#### LEGAL/POLICY:

Section 3.12 of the Local Government Act 1995, as amended, sets out the procedure to be adopted when amending Local Laws.

This requires that the Council approves the amendments before issuing a Statewide and local advertisement seeking public comment on the proposals. After a statutory public consultation period of 6 weeks, any comments or objections are to be considered and reported to the Council for final approval before gazettal.

# STRATEGIC IMPLICATIONS:

In the 2005 – 2010 Strategic Plan, Key Result Area 4, "Leadership & Management", Part 4.5 - "Promote Financial Management".

# FINANCIAL/BUDGET IMPLICATIONS:

There will be small costs associated with the advertising of the proposal.

The increase in parking infringement modified penalties will result in an increase in revenue. It is difficult to accurately calculate the precise revenue to be raised, however it is estimated to be in the vicinity of \$150,000 - \$175,000 (this is based on the number of infringement notices issued in 2004/05).

#### **COMMENTS:**

The above proposal is consistent with the current operating procedures of the Town. The amendments above are recommended for approval.

#### **PURPOSE OF REPORT:**

The purpose of this report is to review and adopt the fees and expenses applicable to Elected Members for 2005/2006, as required by the Local Government Act 1995.

#### **BACKGROUND:**

At the Ordinary Meeting of the Council held on 8 June 2004, the Council approved the Policy - Elected Members Allowance, Fees and Re-imbursement of Expenses, policy number 4.2.7 and approved of the fees and expenses and also made minor amendments to the Council Policy.

# Mayor's Vehicle - Petrol

The increase is to reflect the significant rise in fuel prices which have occurred over the previous year. The current amount of \$50 per week has been marginally increased to \$55.

#### **Child Care Costs**

The re-imbursement for child care costs has not been increased since 1996 when it was set by Local Government Regulation at a maximum of \$10 per hour. Recent amendments to the Regulation have increased the maximum to \$20 per hour. Accordingly, the increase is recommended.

#### **CONSULTATION/ADVERTISING:**

The Council's Policy relating to Elected Member Fees and Expenses was previously advertised for public comment in May 2003.

In view of the very minor nature of the proposed amendments which do not materially affect the principle conditions of the policy, it is recommended that the amendments to fees and expenses not be advertised separately for public comment, but considered as part of the Budget process.

# LEGAL/POLICY:

The Local Government Act provides that a Member has a legal right to be reimbursed for rental on one telephone line and one facsimile line and in addition, can claim child care costs incurred whilst attending to Council business.

The Local Government (Administration) Regulations also provide:

"The extent to which an expense ... can be reimbursed is the actual amount, verified by sufficient information".

The above criteria must be met before any reimbursement can be made. That is:

- the Council must first approve the types of expenses which can be reimbursed (and may set limits to these);
- the expense must be incurred in performing a function as a council member;
- reimbursement is limited to the actual expense incurred; and
- the expense must be verified by sufficient information.

# STRATEGIC IMPLICATIONS:

Nil.

# FINANCIAL/BUDGET IMPLICATIONS:

The above costs associated with this policy are included in the Annual Budget 2005/2006.

# **COMMENTS:**

The expenses and allowances approved by the Town of Vincent are comparable with other local governments of a similar size and budget to the Town of Vincent and no difficulties have been raised.

#### **PURPOSE OF REPORT:**

To present the Draft Budget prepared for the financial year 2005/2006.

# **BACKGROUND:**

The Draft Budget for the financial year 2005/2006 was considered at the Special Meeting of Council on 17 May 2005. At that meeting a number of amendments to the Draft Budget were adopted which have now been included in the revised version of the budget document.

#### **DETAILS:**

# **Draft Budget**

The Draft Budget 2005-2006 as presented proposes the funds for the new capital works as follows:

Land and Buildings	\$32,041,460
Infrastructure	\$3,470,733
Plant and Equipment	\$681,740
Furniture and Equipment	\$137,300

The Town's Administration has prepared the draft budget and has included the following;

- (a) Council adopted programs;
- (b) items that have come from Council resolutions;
- (c) Elected Members' requests;
- (d) ratepayer/resident requests; and
- (e) projects identified by the Town's Administration.

The Town's Administration has used the following criteria to determine project priorities;

The budget for recurrent operating expenditure is \$24,095,801. In addition an allocation of \$949,220 has been made for new operating items.

The rates figure on the summary page of the Draft Budget of \$13,478,431 represents the funds that would be generated from a rates calculation at this point of time using the existing rate in the dollar, therefore taking into account any interim accounts that would be applicable for the full year.

As the summary indicates, if all the works included on the Draft Budget 2005/06 as presented are funded, the Council will need an estimated increase of 3.25% in the rate in the dollar to meet all of the requests, before adjustment for the tri-annual revaluation is made to the rate in the dollar.

#### **CONSULTATION/ADVERTISING:**

The Council's Policy No. 4.1.21 "Community Consultation" prescribes the Draft Budget to be advertised on a local basis for a period of 21 days. Copies are also placed on the Town's Web page, placed in the Library and sent to the Community/Business Groups.

#### LEGAL/POLICY:

#### **Adoption of Budget**

The recent amendments to the Local Government Act 1995 now allows the Council to adopt its budget prior to the end of the financial year 30 June 2005. However, this year the Council will continue with its current practice of adopting the Annual Budget at the first meeting in July.

# STRATEGIC IMPLICATIONS:

The Council's budget process is in accordance with the Council's Draft Strategic Plan 2005-2010, Key Result Area Governance and Management – Action Plan 4.1 (a) "Continue to develop a long term Strategic Vision and Financial Plan to ensure the long term financial viability of the Town."

# FINANCIAL/BUDGET IMPLICATIONS:

The approval in principle of the Draft Budget is essential to maintain the timeframe to allow adoption of the Annual Budget in line with the Council approved timetable.

This will then ensure funding for the operations of the Council for the next financial year.

# **COMMENTS:**

It is considered the Draft Budget 2005-2006 provides funding for a varied capital works programme together with existing and new operational requirements.

It is recommended the Council consider and approve in principle the Draft Budget 2005-2006 and for this to be advertised and issued for public comment.
