

PROPOSED BOUNDARY CHANGE

As you would be aware, the Town of Vincent prides itself on being one of the most highly sought-after and desirable areas for people to live and work in. The Town actively sets out to provide excellent services and maintain and enhance our unique diversity – in our people, our cultures, our buildings, events and places of interest. An independent survey in November 2004 had residents giving the Town an 87% satisfaction rating for the "provision of efficient and effective services".

With an aim to introduce more logical and practical boundaries, the Town of Vincent submitted a proposal to the Local Government Advisory Board (LGAB) to transfer parts of East Perth and West Perth, Glendalough, Mt Lawley, Menora and Coolbinia into the Town. The request for the realignment of boundaries follows natural/physical borders and will benefit both new and existing ratepayers and residents. Not entirely unexpectedly, the City of Perth submitted a counter proposal to the LGAB to assume that part of Vincent south of Bulwer Street and bounded by Bulwer, Vincent and Loftus streets and down to Newcastle Street, in which you live or own property. The Town believes that the proposal is flawed and lacks merit. The City of Perth proposal completely disregards the future viability and sustainability of the Town.

The Local Government Advisory Board has now commenced their deliberations on the proposed boundary changes initiated by the Town of Vincent. The LGAB will soon be seeking the opinions and views of residents and ratepayers and undertaking extensive community consultation. Obviously we are very keen for you and your neighbours to remain in Vincent and continue to enjoy the benefits and services offered by the Town and seek your support in ensuring that your home or business is not transferred to the Central Business District and Capital City-focussed City of Perth.

I hope you will take the time to get involved with the LGAB process and let your opinions be known as the local government authority that manages your area will make a difference to you, your neighbours and the services and facilities available to you to utilise and enjoy. We believe that Vincent has a lot to offer our ratepayers and residents and we trust that you agree and will oppose any attempt to have a vital and important part of Vincent annexed.

I trust you will take the time to seriously consider the implications of the proposed boundary changes and base your decisions on the facts and your observations about the Town and its operations. We are looking forward to the outcome of the LGAB enquiry and hope to continue to provide you and your neighbours with the services and facilities for which the Town is renowned.

Reasons to Oppose the PCC Proposal

The Town's ratepayers and residents should **strongly oppose the PCC proposal** as it is seriously flawed and without merit – it may even be considered a "*tit for tat land grab*" response to the Town's recent proposal to realign the Town's boundary along the Graham Farmer Freeway.

The Local Government Advisory Board will assess the proposal using the following criteria:

1. Matters Affecting the Viability of Local Governments

- The PCC proposal to annex 14% of the Town (including over 4000 residents and approximately 2600 properties) will remove over \$3 million of rates income and will make the remainder of the Town unsustainable and unviable in the long-term.
- The PCC's proposal is totally contrary to the principles of the Local Government Advisory Board.
- It demonstrates a complete disregard for the rest of the Town of Vincent.

2. Community of Interest

- The PCC proposal to annex the area bounded by Lord, Bulwer, Vincent and Loftus streets **erroneously** assumes that that part of the Town of Vincent has a "community of interest" with the Central Business District and Northbridge.
- Nothing can be further from the truth the Town's residents are a part of the residential Precincts of Hyde Park, Cleaver and Beaufort **not** Northbridge or the Central Business District, which is the entertainment and commercial district for the Capital City.

3. Logical Boundaries

- The PCC proposal does not follow distinctive features or major roads.
- The Town's proposal to use the Graham Farmer Freeway as the new boundary follows a major artificial feature and meets the requirements of the Local Government Advisory Board.

4. Demographic Trends

• The demographic trends of this part of the Town of Vincent are **distinctly different** from the business-focussed City of Perth.

5. Economic Factors

• The PCC proposal again erroneously assumes that the Town's residential areas will follow their Northbridge redevelopment – the Town strongly believes that the Town's residential areas must remain predominantly residential and not be amalgamated into a Northbridge-style development.

6. History of the Area

• Whilst it is correct that this part of the Town was a part of the PCC prior to July 1994, many residents will remember that the **area was previously largely ignored by the business-focussed and controlled PCC Council.** There is a strong chance that this will again occur and is not in the best interests of the Town's ratepayers and residents.

7. Transport and Communication

• The PCC's preoccupation with parking is contrary to encouraging better use of public transport. The aspect of the greater use of public transport is strongly supported by the Town.

8. The Effective Delivery of Services

• The Town currently delivers a high standard of service to its ratepayers and residents, as shown in the Town's last Customer Satisfaction Survey:
