PURPOSE OF REPORT:

For Council to accept the tender submission of Iconic Property Services Pty Ltd for both portions of Tender IE258/2023 Cleaning Services.

BACKGROUND:

The City of Vincent has various facilities for sporting and community groups, both public and operational, that require to have scheduled and non-scheduled cleaning services.

The City sought offers from suitably qualified and experienced cleaning contractor(s) to provide cleaning services in accordance with the facility schedules for two separable portions;

- 1. Operational Buildings; and
- 2. Public Toilets, Community and Sporting Facilities.

The contractor(s) will be required to undertake specific tasks on a daily, weekly, monthly basis, as well as periodic, emergency and ad hoc cleaning in line with the City's Building Level of Service framework (BLOS).

Compliance Assessment

Ten (10) of the offers received were assessed as fully compliant and progressed to the qualitative assessment.

- Ranked second in the pricing assessment;
- · References conducted and verified claims; and
- Pricing demonstrates value for money.

It is therefore recommended that Council accepts the tender submitted by Iconic Property Services Pty Ltd for Tender IE258/2023 Cleaning Services.
