#### 10.2 PROPOSED RESIDENTIAL ONLY PARKING RESTRICTIONS, HAROLD STREET, MOUNT LAWLEY - RESULTS OF COMMUNITY CONSULTATION

# **RECOMMENDATION:**

That Council:

- 1. NOTES the comments received during the consultation period (Attachment 1);
- 2. APPROVES the introduction of resident only parking on the northern side of Harold Street, between Vincent Street and Beaufort Street, Mount Lawley; and
- 3. ADVISES consultation respondents and affected residents of its decision.

#### PURPOSE OF REPORT:

To consider the outcome of the recent consultation regarding the proposal to implement resident only parking on the northern side of Harold Street, between Vincent Street and Beaufort Street, Mount Lawley.

#### BACKGROUND:

At its meeting on 14 March 2023, Council requested Administration to consult with the residents of Harold Street, between Vincent Street and Beaufort Street in Mount Lawley, about a proposal to introduce resident only parking on the northern side of the street. This proposal came as a result of a petition received by the residents of Harold Street on 14 February 2023.

# DETAILS:

The petition presented to Council, highlighted that increased patronage to 'The Beaufort', the anticipated increase in vehicles from the 'Challis' apartments and the weekday impact from Sacred Heart Primary School, will continue to add parking pressure on Harold Street and in turn increase the difficulty for residents to find parking.

The volume and demand on parking data from parking surveys showed that the street is generally utilised by more non-residential vehicles.

The City consulted with the residents of the affected section of Harold Street between 22 March 2023 and 14 April 2023. A total of 22 letters were sent. The City received a total of 16 responses, all of which supported the proposal. The results of the comments received are at **Attachment 1**.

The changing of the parking restrictions on Harold Street will be consistent with the current parking restrictions that are in place on Mary Street, which is also adjacent to the Sacred Heart Primary School.

The southern side of the street will remain as 2P parking at all times.

### CONSULTATION/ADVERTISING:

All affected property owners and occupiers within the immediate area of the proposed restrictions were notified of the proposal and asked to provide comment. All responses are at **Attachment 1**.

The City consulted in accordance with the Community and Stakeholder Engagement Policy, by a mail out to all properties on Harold Street, between Vincent Street and Beaufort Street, Mount Lawley.

Note: All persons who commented or provided submissions during the consultation period for this matter, have been notified that this item is going before Council.

#### LEGAL/POLICY:

The City's Parking and Parking Facilities Local Law states the local government may, by resolution, prohibit or regulate by signs or otherwise, the stopping or parking of any vehicle or any class of vehicles in any part of the parking region, but must do so consistently with the provisions of this local law.
