COLLABORATIVE GRANTS

The City of Vincent recognises that community funding provides a significant opportunity to work collaboratively with the local groups, organisations and individuals to deliver activities which increase social participation, promote social inclusion and strengthen connections within our community. A variety of funding initiatives are offered each year to meet the diverse range of interests, demands and priorities throughout the Vincent community.

Collaborative Grants aim to establish partnerships between the City of Vincent and service delivery agencies that reside and/or operate within our local community in order to effectively respond to a recognised community focus area as determined by Council. This focus area will be reviewed on an annual basis to ensure alignment with Council priorities and community needs.

The City of Vincent has available Community Funding for Collaborative Grants up to \$85,000.

Before starting your application, please contact the Community Partnerships Team to discuss the proposed activity, event or program.

KEY FOCUS AREA - 2017/18

Projects seeking funding through Collaborative grants are encouraged to demonstrate a partnership approach to providing tools to empower individuals experiencing homelessness to improve their physical, emotional, spiritual and/or mental wellbeing.

This funding is for projects that respond to the challenges of homelessness within our community. We provide funding to projects that build capacity, deliver change and real outcomes and have the potential to continue after the funding period.

Applications submitted may be an existing program already within the City of Vincent or seeking to expand into the City of Vincent or a pilot project reflecting new collective support for individuals experiencing homelessness.

GUIDELINES AND CRITERIA

In order to be eligible for funding, your organisation must:

- Be a legal entity in Australia (incorporated association) or be auspiced by an appropriate organisation;
- Be a community group that falls into one or more of the following categories:
 - A not-for-profit community organisation;
 - $^{\circ}$ A registered charity with the Australian Taxation Office;
 - A deductible gift recipient; and/or
 - A social enterprise; and

What will be considered for funding:

- A collective group of organisations working in partnership to address the key issues associated with homelessness in the City of Vincent. (Collaborative projects must have a lead agency)) or a single organisation aiming to develop meaningful partnerships with other organisations and stakeholders within the City through the project;;
- Operational salaries (salaries tied to a project will be considered, no more than 75% of the funding may be allocated to salary expenses);
- Projects that can commence by 30 January 2018 and will be in full operation by 30 June 2018;
- Projects that demonstrate how the organisation/s or project/s are able to become more sustainable and less reliant on government support to prosper will be favourably regarded;
- Projects that provide individuals experiencing homelessness, opportunities and support to live independently to reconnect within their community, improve their health and wellbeing and develop pathways to education, employment and training;
- Grant applications that demonstrate initiatives, services, projects and resources that contribute to the goal of

providing wrap-around services to support those experiencing homelessness will be favourably regarded;

- Applications that contain capital expenditure items must be able to demonstrate that this will allow further or new service provision and support;
- Only projects with measurable outcomes will be considered. Applications need to outline how outcomes will be measured;
- The grants round is a competitive application process, which means your application may not be successful if your submission is not adequately justified; and
- The City must be satisfied that the lead organisation has the competency and capacity to implement the project.

The following will not be considered for funding:

- Groups and organisations that operate with the aim of making a profit;
- Groups and organisations who have failed to acquit grants awarded to them by the City of Vincent in any capacity;
- Capital expenditure that does not demonstrate further service provision and/or support;
- Debt reduction or operational deficits;
- Religious organisations where the grant is intended for the principal benefit of the organisation's own members or adherents, or where the grant is intended for inherently religious activities;
- Legal expenses;
- General construction, capital campaign or renovation unrelated to a specific proposed project or program;
- Travel outside Australia;
- General fundraising appeals; and
- Retrospective funding.

ACOUITTAL

Financial acquittal and evaluation report will be due within 60 days of project completion, no later than 31 August 2017.

Please be aware that your organisation will not be eligible for any further funding from the City of Vincent unless an acquittal has been received.
