



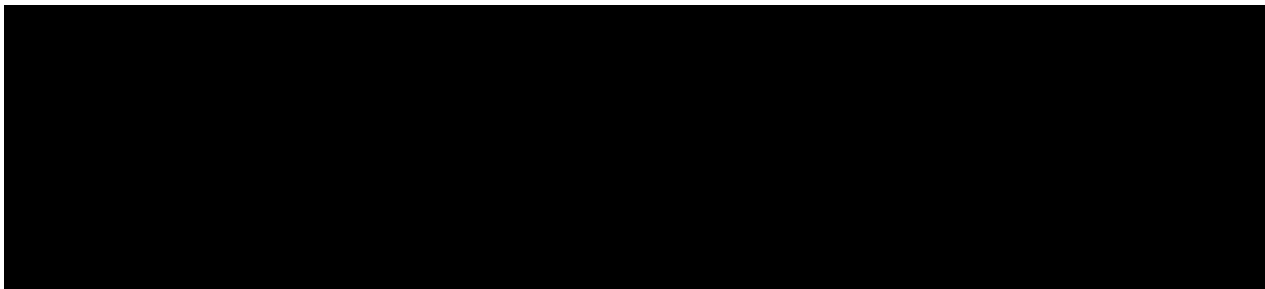

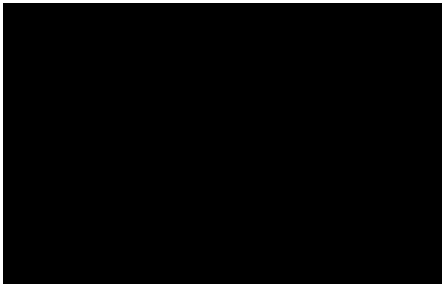

## PERMIT CONDITIONS

- The area of operation must be adequately signed and barricaded from vehicles and pedestrians. Full temporary signage is to be in place when lane is obstructed in accordance with AS 1742.3
- The City is to be indemnified against any claim or action arising from the operation.
- Barricades must be used to provide safe movement of pedestrians together with safe access for pedestrians being provided at all times.
- The movement of all path users, with or without disabilities, within the road reserve shall not be impeded during building works.
- Access to residential properties and businesses is to be maintained at **ALL** times.
- The requirements of the Work Safe Western Australia **must** be complied with at all times.
- Any damage to road or footpath must be repaired at the applicant's expense in accordance with City's specifications within 24 hours.
- Hours of work to comply with Environment Protection (Noise) regulations 1997.
- The Applicant is to employ a Main Roads Western Australia accredited traffic management organisation to supply and implement traffic management, and a copy of the organisations traffic management plan is to be supplied to the City of Vincent's Technical Services Division prior to the commencement of works.
- Applicant is to re-apply before expiry date of permit, if works are to continue beyond permit expiry date.
- Failure to comply with the Permit conditions is an offence. The City reserves the right to cancel the permit, if the above conditions are not adhered to.
- City reserves the right to amend the conditions of the permit and/or request immediate removal of the site fence without prior notice at anytime.
- The City of Vincent reserves the right to cancel this permit at any time in accordance with section 3.15 of the *Local Government Property Local Law 2021*.
- Emergency vehicle access is to remain available at all times.
- All works are to comply with the approved Traffic Management Plan and relevant legislation, standards and City requirements.
- Any damage to road or footpath must be reported to the City immediately and repaired, at the applicant's expense, in accordance with City's specifications within 24 hours. Appropriate warning signs (in accordance with AS1742.3) are to be erected and temporary pedestrian facilities suitable for all users are to be installed while repairs are carried out.
- The support shoes of a free-standing fence must not present a trip hazard to pedestrians or create a liability, and must be:
  - Rotated to be parallel with the fence or positioned behind the fence or fully contained within the worksite.
  - Appropriately braced.
  - Regularly checked to ensure the fence is not moved out of the approved alignment.
- Where the site fencing protects an excavation of a depth exceeding 500mm, the structural adequacy of the hoarding/fence is to be certified by a practising Professional Engineer who is a member of the Institution of Engineers Australia, confirming compliance with AS/NZS 1170.
