

### AGED OR DEPENDENT PERSONS' DWELLINGS

#### What is an aged or dependent persons' dwelling?

The Residential Design Codes (R-Codes) provides the following definitions:

#### Aged person

A person aged 55 years or over.

#### Dependent person

A person with a recognised form of disability requiring special accommodation for independent living or special care.

#### Dwelling

A building or portion of a building being used, adapted, or designed, or intended to be used for the purpose of human habitation on a permanent basis by a single person, a single family, or no more than six persons who do not comprise a single family.

#### Do I require development approval?

Development approval is not required for aged or dependent persons' dwellings if they satisfy all of the deemed-to-comply requirements of the City of Vincent's Built Form Policy, and the provisions contained within the R-Codes. The land use must also be deemed a permissible use for the property's zoning, as per the Local Planning Scheme No. 2.

If your aged or dependent persons' dwelling design does not satisfy all of these requirements, you will need to submit an application for development approval to the City for consideration.

### Who can live in an aged or dependent persons' dwelling?

The R-Codes require that at least one occupant meets one of the above definitions or is a surviving spouse of such a person.

#### What are the general requirements for aged or dependent persons' dwellings?

There are additional requirements specific to aged or dependent persons' dwellings contained within the R-Codes. The table below outlines the R-Codes deemed-to-comply requirements relating to aged or dependent persons' dwellings, including an explanation of how each requirement should be interpreted, and how this can be satisfied.

Deemed-to-Comply Requirement	How this can be achieved
Site Area  Developments must comply with the dwelling type and site area requirements applicable to the site's density code, as indicated in Table 1 of the R-Codes Volume 1.	Details of your property's site area and density code or zoning can be found on the City's online mapping tool <a href="Intramaps">Intramaps</a> .
Variations to Site Area Site area requirements may be reduced by up to one- third of those set out in Table 1 of the R-Codes subject to the compliance with clauses 5.1.1, 5.5.2 and 5.5.3.	Information on the minimum site area requirements for residential developments can be found in Table 1 of the R-Codes Volume 1.
Plot Ratio Area Single houses or grouped dwellings are to have a maximum plot ratio of 100m².	Plot ratio means the total area of all floors of a building including internal and external walls, but not including:  • areas of any lift shafts;

Multiple dwellings are to have a maximum plot ratio of 80m².	<ul> <li>machinery, air conditioning and equipment rooms;</li> <li>space wholly below natural ground level;</li> <li>areas used exclusively for parking of vehicles;</li> <li>storerooms;</li> <li>lobbies, bin storage areas;</li> <li>balconies, eaves, verandahs, courtyards, and roof terraces.</li> </ul>
Number of Dwellings The number of dwellings is provided in accordance with the minimums outlined in R-Codes clause 5.5.2, C2.1ii.	Any single development must have a minimum of five dwellings.
Car Parking Car parking is provided in accordance with the R-Codes clause 5.5.2 C2.1iii and iv.	Visitors parking spaces are provided at a rate of one per four dwellings, with a minimum of one space provided.  The first visitor's car parking space must be a wheelchair accessible car parking space, with a minimum width of 3.8m in accordance with AS 4299:1995, Adaptable Housing clause 3.7.1 (as amended).
Outdoor Living Areas Outdoor living area must be provided in accordance with the requirements of R-Codes clause 5.3.1.  Variations to Outdoor Living Area Requirements Density concessions may be applied reducing the minimum outdoor space requirements indicated in Table 1 to one-third.	Outdoor living areas shall be:  i. behind the street setback area;  ii. directly accessible from the primary living space of the dwelling;  iii. a minimum length and width dimension of 4m;  iv. at least two-thirds of the required area without permanent roof cover.  Each multiple dwelling must provide at least one balcony or the equivalent, opening directly from the primary living space and with a minimum area of 10m² and a minimum dimension of 2.4m.
Ground Floor Unit Requirements All ground floor units, with a preference for all dwellings, must meet the minimum requirements of R-Codes clause 5.5.2, C2.2.	As a minimum, all ground floor units shall incorporate:  1. an accessible path of travel from the street frontage, car parking area or drop-off point must be provided in accordance with the requirements of AS4299, clause 3.3.2 (as amended); and  2. 2. level entry to the front entry door. Preferably all external doors shall have level entries.
Requirements for All Dwellings All dwellings are to comply with the minimum requirements of R-Codes clause 5.5.2, C2.3.	As a minimum, all dwellings shall incorporate:  1. a minimum of 820mm clear opening provided in all external and internal doors;  2. a minimum width of 1000mm for internal corridors, increasing to a width of 1200mm in corridors with openings on side walls;  3. a visitable toilet, preferably located within a bathroom (AS4299, clause 1.4.12 [as amended]);  4. toilet and toilet approach doors shall have a minimum 250mm nib wall on the door handle side of the door and provision for the installation of grab rails in accordance with AS4299, clause 4.4.4 (as amended).

### Occupancy Requirements

The R-Codes requires that at least one occupant is a disabled or physically dependent person or aged person, or is the surviving spouse of such a person, and a section 70A notification on the Certificate of Title is lodged.

A section 70A notification on the Certificate of Title must be lodged as a condition of development approval. This notification requires the owner and prospective proprietors be made aware of the occupancy restrictions requiring to be maintained.

#### Other Requirements

All single house(s), all grouped dwellings, and multiple dwellings in areas coded less than R30 are required to comply with all other provisions of Table 1 and Part 5 of the R-Codes as relevant.

Multiple dwellings in areas coded R30 or higher must comply with the Part 6 provisions of the R-Codes.

The general site requirements and design elements for all single house(s), all group dwellings, and for all multiple dwellings in areas zoned less than R30 are contained within the R-Codes Volume 1, here.

Multiple dwellings in areas coded R40 or greater are controlled by the general site requirements and design elements contained within R-Codes Volume 2, here.

#### What if I do not meet the requirements specified above?

Where a proposal does not satisfy any of the above requirements, development approval is required. You can discuss the information required to lodge an application with the City's Urban Planners. Urban Planners can provide general advice to applicants to confirm how these requirements can be satisfied in line with the R-Codes.

#### Can a development contain dwelling types other than aged or dependent person' dwellings?

Yes – developments can be comprised of a mixture of dwelling types to cater for different ageing-in-place needs.

#### What are the Liveable Housing Design Guidelines?

Liveable Housing Australia have developed seven core design elements which can be incorporated into new or existing dwellings to help meet the changing needs of occupants across their lifetime. The <u>Liveable Housing Design Guidelines</u> (LHDG) outline the design elements necessary to achieve Silver, Gold and Platinum Levels Accreditation.

These guidelines offer voluntary structural and spatial design elements which can be incorporated into dwellings to allow for future flexibility and adaptability. The City strongly encourages the development of housing which incorporates these design elements. The National Construction Code (NCC) and Building Code of Australia (BCA) Volumes 1 and 2 set out the legal requirements for all building work and take precedence over the LHDG.

#### Do I require building approval?

Applying for development approval and a Building Permit are two separate processes, both controlled under different legislation. A Building Permit ensures that the building is structurally safe and complies with the relevant building legislation and is required for all aged or dependent persons' dwellings.

#### What information is required for a Development Application?

#### How long does the planning approval process take?

The City has 60 days in which to determine the application or 90 days if the application requires community consultation. Clause 75(c) of the Planning and Development (Local Planning Schemes) Regulation 2015 states that applications may take longer than 90 days where it is agreed to in writing between the local government and the applicant.
