4.1 Smoke Free Town Centres (CD) (refer **Attachment 1 - Smoke Free Town Centre Maps**)

We are seeking community and business feedback on the draft boundaries for five smoke free Town Centres (a priority in our Public Health Plan 2020 – 2025). The Town Centres include – Leederville, Mount Hawthorn, Beaufort Street, North Perth and William Street.

Why?

The reason for this project is to reduce community exposure to harmful environmental tobacco smoke and create healthy environments for people to live, work and play. Eighty-five percent of the community highlighted that smoke free environments were important for their health and wellbeing as there is no safe level of exposure to environmental tobacco smoke which can be the cause of preventable disease and premature death.

What?

The City has drafted smoke free Town Centre boundaries for consultation where smoking would not be permitted on public land. This would include public footpaths and public open spaces such as parks within a smoke free Town Centre boundary.

Please note, the smoke free boundary would not affect a business that allows smoking on their private land but the City is will start conversations with any business that wish to become smoke free and the benefits for staff and customers.

Criteria for smoke free area in Town Centres

Administration considered the following before drafting the smoke free areas

- Town Centre Boundaries;
- Size of the boundary;
- Location of the Entertainment strips which included licenced premises, cafes, and restaurants;
- Public open spaces;
- Clear boundaries where smoke free area can start and finish (e.g. main roads and intersections, prominent landmark).

Consultation Workshop

We will be delivering localised workshops in the five Town Centres throughout June – August 2021 and will invite local businesses and community members to discuss the smoke free areas and answer any questions
