3. BUSINESS ARISING

3.1 CHAIR AND VICE-CHAIR NOMINATIONS

- o Cr Sally Smith nominated and approved as Chair
- o Tara Gloster nominated and approved as Vice-Chair

3.2 ADOPTION OF TERMS OF REFERENCE

- o Local businesses can be invited as noted in the Terms of Reference
- o Terms of Reference adopted without modifications

3.3 DRAFT PUBILC HEALTH PLAN CONSULTATION

- o Consultation closes Friday, 11 September
- o Consultation information to be sent to meeting attendees
- o Town Teams to share the consultation information with their databases



- Smoke free town centres by 2025 is the over-arching target of the document
 - It is confirmed that consultation will include licensed venues
 - It is confirmed that this target does not include private outdoor areas
 - This is the only target, but the key deliverables included in the plan all contribute to the health outcomes and objectives
 - Question regarding if homelessness, mental health, and other community services have been consulted. How will this target limit access to the town centres for these groups?
 - It is confirmed there is additional best practice research to be done with respect to implementation
 - It is noted that Cr Hallett requested the Public Health Plan be consulted with community service providers as a whole
 - It is noted that vaping should also be included in this target
- Question regarding how the Public Health Plan priorities were set
 - It is noted the State Public Health Plan sets key priorities for the State, which are then assessed for relevancy and importance to the City.
 - Health statistics and community consultation guided this assessment

3.4 DRAFT DEVELOPMENT ON CITY OWNED AND MANAGED LAND

- o Consultation closes Friday 25 September
- Place Managers to send consultation information to the Town Teams
 - Submissions are encouraged to include examples of how the current draft policy may impact Town Teams to assist in clarifying the scope and intent of the policy moving forward
- Concern surrounding the privatisation of the public realm
 - It is confirmed that the purpose is to provide transparency regarding who the decision maker is, how the decision will be made, and what approval is needed
- Concern how this policy may impact Town Team cultural activities such as public art, including additional costs
 - It is noted that the intent of the policy is to give more thought toward permanent structures in the public realm
 - Idea to investigate a "cash-in-lieu" contribution at commercial lease rates for permanent structures in the public realm
 - Should depend on how important that piece of the street is (e.g. corner site vs mid-block)
- There is a need for the policy to give clear guidance regarding the spirit of the policy, and for the impacts of these developments to be monitored
 - Suggestion of a KPI regarding if it's possible to sit anywhere in the town centres for free
 - More education is required for businesses about the outward impact of developments in the public realm

3.5 NAIDOC WEEK

- To be hosted in the Pickle District 8-15 November
- RE to liaise with the Pickle District Town Team regarding additional events and activations they have planned for NAIDOC Week
 - It is noted that there are youth grants available which could provide support for artists and entrepreneurs under 25 to undertake additional activities in the Pickle District

3.6 CHRISTMAS CAMPAIGN

- Survey to be sent to Town Teams to gage what they see the most value in (e.g. events, marketing, decorations, etc), and when they'd like to see Christmas launched
 - It will launch post NAIDOC
 - It is noted that earlier is better as things tend to slow down two weeks before Christmas



4. GENERAL BUSINESS

4.1 VINCENT REBOUND PLAN

- The document is designed to evolve over 24 months
 - It is noted that an ongoing conversation is needed as things continue to change post-COVID
 - There is a need to rethink the forum for this conversation as one hour is not enough time
 - A doodle poll is to be sent out to find a suitable evening time for this meeting going forward as it is easier to have these conversations in person
- Future action/consideration section to be added to working Rebound Plan to capture initial ideas from Rebound Roundtables

4.2 TOWN TEAM UPDATES

- o North Perth Local is in the planning stages of a Christmas party in North Perth Common
- Leederville Connect in in the process of updating their website, which will enable better social media content and communications
- Beaufort Street Network serenade event went well. Restaurants reported a general increase in bookings.
- Mount Hawthorn Hub has upgraded their website recently. JS would like to bring additional Hub members to the next meeting – discuss this with SS offline
- Northbridge Common is currently preparing a proposal for a 230m² space on Washing Lane which can become a community hub/co-op/incubator/multi-use events/arts space. They are currently formalising funding sources and investigating a 1-2 year lease
- Pickle District has procured a sea container with a fold out stage and is investigating placement. To be used as a community hub/space
- Town Team Movement Convergence is set for 17 October on Beaufort Street. The emphasis will be on public open space in town centres. This year is the first year it is also open to Local Governments and other community groups to attend
