1. Welcome / Declaration of Opening

3. Business

3.1 Pedestrian and Cyclist Access

3.1.1 North Perth Common – View St Carpark

FS presented images of North Perth Common and raised issue of pedestrian and cyclist access. Discussion ensued. SL advised balance of View Street (north of planned Common) could have a Safe Active Street treatment. LD considered possible left only turn onto Fitzgerald and also onto Angove (from the Rosemount carpark).

3.1.2 Axford Park

Concept presented. JH advised much still hinges on the proposed development to the immediate north of the park. SL advised of need to ensure separated east bound bike lane remained. Discussion ensued.

3.1.3 Oxford Street North

FS presented concept. LD recommended a central 'green' cycle lane at the approach to the SBR intersection. SL also added that the intersection be 'tightened'. Comments to be included as design progresses.

3.2 Leederville Town Centre & Street Closures

JH advised that this had been raised by GK via Loomio. GK advised that single events where road closures occurred were not representative of the potential positive impacts. Regular scheduled closures would result in more predictability for visitors and retailers.

3.3 Tactical Urbanism

LD presented on tactical urbanism – 'short term interventions leading to long term changes' and the possibility of implementing in Vincent. Discussion ensued about how valuable these low cost interventions are in leading to change. Key element is that these actions are bottom up – led by the community with the local government supporting.

CoV to consider where possible actions could happen without incurring Main Roads concerns/involvement.

3.4 **40KMH Speed Zone Trial**

AM advised consultation closes next week and urged any members to complete surveys and encourage their networks to do so.

3.6 WALGA Road Safety Report

KC advised of increase in fatalities on WA roads compared to last year. Also advised that two safety campaigns are being rolled out including "We're watching your speed, Are You?" Also, orders are being taken for 'Please consider our kids' bin stickers through the RSC. CoV Waste is already onto it and is ordering stickers.

3.7 Glendalough Station Access

FS advised of PTA offer to prepare some better PSP connections to the Glendalough train station (and also the imminent PSP upgrade from Glendalough to Hutton Streets). Showed slide of area of improvement focus including Tasman Street. PTA will be submitting a report with actions in the near future.

3.9 WABN Grant Application – Florence/Carr Streets

FS advised that an application for funding has been made to the DoT's next round of funding for the 2019/20 financial year to build the Florence/Carr bike lanes. For the sake of the funding application, the project has been split into two stages as estimated construction costs are higher than expected. CoV engineering are to review the construction estimate.
