Further to this, a street tree strategy be developed that takes into account three aspects equally – health, ecology and a sense of place with a priority going to native West Australian trees.

Clarifying Discretion Policy:

That the City, as a matter of urgency, and as an interim measure until the planning policy review is complete, amend policy 7.5.11 (Exercise of Discretion) to make it clear that where a bonus is contemplated, the deemed to comply plot ratio will be modified in line with the proposed bonus (e.g. where a bonus is sought to allow an additional storey in an area with a prescribed height of three storeys, the deemed to comply plot ratio will increased by 33%).

Disability Access and Inclusion:

- 1. That the Council notes that the Oxford Street Park development did not meet universal access requirements and needed subsequent modification at an estimated cost of \$18,000;
- 2. That the City's adopted Disability Access and Inclusion Plan (DAIP) states that infrastructure design will incorporate enhanced, as opposed to minimum, access standards, and therefore the omission of appropriate access was contrary to the DAIP; and
- 3. Requests the Chief Executive Officer to provide details of the steps that were taken, and when they were taken, to ensure that this problem does not happen again, therefore demonstrating the City's commitment to the DAIP.

- 2. That elected members be required to provide details of how they spent the allowances they have received in the past; and
- 3. That the City review the above policy with a view to the City providing the required infrastructure, or to identifying the level of support that is deemed reasonable.

That Council investigate amending the Planning Scheme so that new multiple storey developments on sites of 1,500 square metres and over need to have an equal amount of site area in greening on the building in the form of roof gardens, vertical walls and/or green balconies.

# 4.10 Alan Skinner – 5 Gill Street, North Perth

Regarding the development at 92 Sydney Street, North Perth.

Mr Skinner queried why the current application for retrospective approval is not on the City's website. It is an application that deserves public comment.

The Director Development Services took the question on notice and advised that as far as she is aware the application has been advertised and would be on the website for the period of the advertising. It is possible that it has come to the end of the advertising or alternatively, that it has not started advertising yet. Either way, when a planning application gets considered for the period that public comment is being sought, it is published on the website.

Mr Skinner stated that he believed this is incorrect and that the application for retrospective approval was lodged some 3-4 weeks ago and has never appeared on the website and he was informed by the Director that it would be determined by Council in March 2016, but it has not yet appeared on the website. Mr Skinner advised that he wrote to the City more than 2 weeks ago asking the question as to why this application was not advertised and a response has not yet been provided.

The Mayor advised that a formal response will be sent and if it has not been advertised it will need to be advertised.

Mr Skinner was concerned with further delay because the development is continuing and will continue to fruition to ultimate completion and he is concerned for the owners of No. 92 Sydney Street, North Perth that they are continuing to spend money on a development which he believes is illegal which is half a metre above what is approved and any further delay is unfair to the owners and neighbours of which he is one.

The Chief Executive Officer advised that he and the Director Development Services will meet with Mr Skinner to discuss this matter in more detail.
